For over two years, journalist Gonnerman shadowed newly released prisoner Elaine Bartlett, providing an intimate glimpse into the many difficulties associated with attempting to reassimilate into a society that is ill-prepared and often unwilling to assist ex-convicts. Gottschalk, Marie. The Prison and the Gallows. The Politics of Mass Incarceration in America. Cambridge NY: Cambridge University Press, 2006. This book examines the development of four key movements that have mediated the unprecedented rise in the carceral state in the U.S.—the victims' movement, the women's movement, the prisoners' rights movement, and opponents of the death penalty—to investigate the roles that particular social movements and interest groups have played in forging punitive penal policies. Harcourt, Bernard. Against Prediction. Profiling, Policing, and Punishing in an Actuarial Age. Chicago IL: University of Chicago Press, 2007. From routine security checks at airports to the use of risk assessment in sentencing, the employment of actuarial methods in law enforcement is increasing. While many see these methods as a cost-effective way to fight crime, this book challenges a growing reliance on them, arguing that such tools may actually increase the overall amount of crime in society and distort our ideas of just punishment. Jacobson, Michael. Downsizing Prisons. How to Reduce Crime and End Mass Incarceration. New York NY: New York University Press, 2005. In this book, Jacobsen, who oversaw the country's largest city jail system, examines changes in the legal system since 1975 that have led to a spectacular rise in the general prison population, including mandatory minimum sentencing, parole agencies intent on sending people back to prison, three-strike laws, and for-profit prisons, arguing that mass incarceration will neither reduce crime nor create more public safety. Magnani, Laura & Harmon Wray. Beyond Prisons. A New Interfaith Paradigm for Our Failed Prison System. Minneapolis MN: Fortress Press, 2006. This strong indictment of the current prison system traces its history and features, and develops a new paradigm of criminal justice based on restorative justice and reconciliation. Doheny: HV9950.M24 2006

Miller, Jerome. Last One Over the Wall. The Massachusetts Experiment in Closing Reform Schools. Columbus OH: Ohio State University Press, 1998. This book is an analytical and autobiographical account of Miller's tenure as head of the Massachusetts juvenile justice system, during which he undertook one of the most daring and drastic steps in recent juvenile justice history—closing reformatories and returning offenders to community supervision and treatment by private schools and youth agencies. Rodriguez, Dylan. Forced Passages. Imprisoned Radical Intellectuals and the U.S. Prison Regime. Minneapolis MN: University of Minnesota Press, 2006. While the dramatic rise of America's prison system has devastated lives and communities, it has also transformed prisons into primary sites of radical political discourse and resistance, as prisons have become home to a growing number of writers, activists, poets, educators, and other intellectuals. Engaging with a wide range of texts and focusing on the conditions under which imprisoned intellectuals live and work, Rodríguez argues that the cultural production of Mumia Abu-Jamal, Angela Davis, Leonard Peltier, George Jackson, José Solis Jordan, Ramsey Muniz, Viet Mike Ngo, and Marilyn Buck should be understood as a social and intellectual movement in and of itself. Talvi, Silja. Women Behind Bars. The Crisis of Women in the U.S. Prison System. Emeryville, CA: Seal Press, 2007. Even as they increase dramatically, there has been little public discussion about the rise in the number of women prisoners. This book investigates why American girls and women are being locked up at such unprecedented rates, weaving together interviews with inmates, correctional officers, and administrators to provide readers a glimpse into the impact incarceration has on our society. Cornerstone Theater Company: From 1986-1991, this ensemble worked in rural communities, creating musical productions involving interaction between classic plays and American communities (such as Aeschylus's ancient rituals on a modern Native American reservation). Since relocating to LA in 1992 to begin their urban residency work, Cornerstone has developed communitybased projects involving communities of faith, LA neighborhoods and workplaces, and "communities that share culture and language, age, birthday, and transportation."

Center for Diversity and Democracy: Affiliated with USC's Department of American Studies and Ethnicity, the CDD works with students, faculty, and community partners to strengthen a diverse set of voices within the university, while enabling "a wide variety of community members and organizations to engage the university as equal partners towards equity and social justice."

Real Cost of Prisons Project: This site, dedicated to increasing the organizing capacity of prison/justice activists working to end mass incarceration, has excellent resource lists and a blog.

Critical Resistance: Critical Resistance is a leading prison activist organization whose recent conference (Sept 26-8) was the year's major gathering of prison activists and analysts. The CR-10 Publications Collective also edits Abolition Now: Ten Years of Strategy and Struggle Against the Prison Industrial Complex.

ACLU of Southern California: This organization's Jails Project focuses on the LA County Jail system and what can be done to fix

Youth For Justice: This site is run by LA's leading advocates for youth justice, the Youth Justice Coalition.

Homies Unidos: This organization works on deportations and gang issues in Pico Union & Central America.

A New Way of Life Reentry Project: This project helps women and girls break the cycle of entrapment in the criminal justice system and lead healthy and satisfying lives.
