- Michele Bratcher Goodwin is a global thought leader and advisor on issues of law, society, and health.
- Goodwin is Chancellor's Professor and the founding director of the Center for Biotechnology and Global Health Policy at UC Irvine, and the author of *Policing the Womb: Invisible Women and the Criminalization of Motherhood*, among other books.

"When we think about reproductive rights, so much of that has been gleaned through a lens of thinking only about abortion and abortion access. If you were to compare that with the narrative of civil rights, there are some glaring distinctions. Within the case of civil rights, we understand it to be broader than just simply access to education. . . . employment, access to accommodations, housing, and other areas were also implicated by civil rights. If we're to think about reproductive rights, my argument is that we need to be as broad and expansive there too. These are not just matters of abortion. These are matters of being able to be dignified in one's own body, whether it is to choose to terminate a pregnancy, to carry a pregnancy to term, to have access to birth control, to have access to education such as sex education, the right to be free from state surveillance and criminalization..."—Michele Bratcher Goodwin in a March 2021 lecture at the Centre for Criminology and Sociological Studies at the University of Toronto

## MICHELE BRATCHER GOODWIN

Michele Bratcher Goodwin is Chancellor's Professor and the founding director of the Center for Biotechnology and Global Health Policy at UC Irvine's School of Law, where she teaches bioethics, constitutional law, family law, health law, reproductive rights, and torts. She is the recipient of the 2020-21 Distinguished Senior Faculty Award for Research, the highest honor bestowed by the University of California.

Goodwin is the author of *Policing the Womb: Invisible Women and the Criminalization of Motherhood*, *Baby Markets: Money and the New Politics of Creating Families*, and *Black Markets: The Supply and Demand of Body Parts*. She is also an active public intellectual. She hosts the podcast *On the Issues with Michele Goodwin* and writes about law, society, and global health in outlets including the *New York Times*, *L.A. Times*, *Forbes*, and *Ms.*

## VOCABULARY CORNER

**bioethics** – the multidisciplinary study of, and response to, moral and ethical questions relating to the health-related sciences, including biology, medicine, and technologies



**health disparities** – preventable differences in the burden of disease, injury, violence, or opportunities to achieve optimal health that are experienced by different social groups




**health care disparities** – differences between social groups in health insurance coverage, access to and use of health care, and quality of care

**health equity** – when every individual has the opportunity to attain their highest level of health through the elimination of disparities

**reproductive health** – a state of well-being in matters of the reproductive system and its functions and processes; as defined by the WHO, “[r]eproductive health implies that people are able to have a satisfying and safe sex life and that they have the capability to reproduce and the freedom to decide if, when and how often to do so”

**reproductive justice** – “the human right to maintain personal bodily autonomy, have children, not have children,





and parent the children we have in safe and sustainable communities,” in the words of SisterSong: Women of Color Reproductive Justice Collective
