## Works In Progress / Future Research Projects

### **“Leveraging Your Faculty Senate Library Committee.” [working title]** (For submission to *College and Research Libraries News*—conceptual stage)

A review of more than 100 faculty senate web sites reveals that many have a committee devoted to recommending general policies for the development and utilization of the institution’s libraries . These groups represent a valuable link between librarians and faculty and, in some cases, between librarians and senior academic leadership. This essay outlines how these linkages can be utilized in ways that support and promote the library’s contributions to a university’s overall educational mission.

### **“An Envisioning Exercise for Planning-to-Plan a New Academic Library.”** (For submission to *College and Research Libraries*—draft manuscript on file with author).

The research of Donald W. Meinig is used to recast the planned library as a dynamic cultural landscape that extends beyond physical structures and the materiality of occupied spaces. Based on this model, this study proposes an intra-organizational planning-to-plan exercise intended to envision a proposed new academic library facility around a common set of fundamental assertions. The benefits and potential challenges of contemplating multiple visions of the same possible future library is described in relation to the overall planning and design process.

### **“Qualitative Research in the Field of Academic Librarianship: A Select Review and Synthesis of the Literature.”** (For submission to *portal: Libraries and the Academy*—draft manuscript on file with author).

A method of critical content analysis is used to examine the growth and application of qualitative research methods in the peer-reviewed literature of academic librarianship with a focus on research themes, data sources, and methodological refinements. Findings are used to recommend the utility of qualitative research methods applied to problems in academic librarianship and to identify gaps in knowledge that could be addressed by using qualitative techniques of data gathering, interpretation, and reporting relevant to current practice.

### **“Access to Information as a Fundamental Human Right.”** (Working title). (Co-authored with Dr. Alison Renteln, Professor of Political Science, University of Southern California). (Publication TBD—manuscript outline on file with authors).

Article 19 of the *United Nations Universal Declaration on Human Rights* provides a basis for understanding access to information as a fundamental human right. This study explores efforts by world governments to control access to information and reviews selected cases in international law to identify facts, evaluate claims, and examine arguments made by governments to justify controlling access to information. The study argues for an international framework of global norms and institutional arrangements that advance access to information as a fundamental human right.

### **“The Rhetoric of Professional Change and Transformation: Analysis of Statements of Concern by Candidates to the American Library Association Council, 1985-2020.”** (Funded research for submission to *Organization Studies* or the *Annual Review of Organizational Psychology and Organizational Behavior*—manuscript outline on file with author).

Ballots for the positions of American Library Association officers and Councilors are accompanied by the candidate’s statement of professional concerns. This study analyzes the dialogic properties of candidate’s statements over time to analyze how patterns of change and transformation within the field of academic librarianship are expressed by those seeking positions of leadership. Data is also used to highlight and affirm statements about core values identified by candidates and to explore broader conceptualizations of professional service identity.



**“The Cultural Construction of Information: Interpreting Stories of Information-Seeking Behavior.”** (For submission to *Libraries & the Cultural Record*—conceptual stage).

Using diaries, memoirs, personal papers, and autobiographies, this study explores stories of information needs and information-seeking behavior across cultures to illuminate the understandings people hold about the value of information. The essay addresses aspects of the materiality of information, including intellectual property, information as a commodity, and information as a public good. Findings are used to formulate a cultural model of information seeking behavior applied to the practice of library service provision.
